Samayawardhena, J.

The three petitioners filed this application on 04.10.2019, alleging that their fundamental rights guaranteed under Articles 12(1) and 14(1)(g) of the Constitution were violated by the respondents through the appointment of the 15th to 18th respondents to the post of Technical Administrator, pursuant to the board decision dated 31.07.2019, marked P17. This Court granted leave to proceed on the alleged violation of Articles 12(1) and 14(1)(g) of the Constitution.

The petitioners and the 15th to 18th respondents are employees of the 1st respondent, the Sri Lanka Rupavahini Corporation. Applications were called for internal promotions to the post of Technical Administrator, Grade JM 1-1, in respect of 20 vacancies. Following the interviews, candidates who secured 80 marks or more were promoted to the said post, and the vacancies were accordingly filled. This process took place in 2014. The petitioners were not among those selected at that time.

The complaint of the petitioners is that the promotion of the 15th to 18th respondents in 2019 to the said post is in violation of Articles 12(1) and 14(1)(g) of the Constitution. Their contention is that, according to the “waiting list” tendered by the petitioners marked P7, they ought to have been promoted to the said post.

According to P7:

The 1st petitioner is listed at No. 24 on the waiting list and had obtained 79 marks at the interview.

The 2nd and 3rd petitioners are placed at Nos. 29 and 30, respectively, and had each secured 77 marks.

The 15th respondent is listed at No. 23 on the waiting list, with 79 marks at the interview.

The 16th, 17th, and 18th respondents are placed at Nos. 26, 27, and 28, respectively, and had each obtained 77 marks.

If I may go by the waiting list tendered by the petitioners themselves, it was unjustifiable to have promoted the 16th, 17th, and 18th respondents over the 1st petitioner, as the 1st petitioner had obtained higher marks than each of them.

On the other hand, although the 2nd and 3rd petitioners obtained the same marks as the 16th, 17th, and 18th respondents, they were ranked lower on the waiting list. Moreover, the 16th, 17th, and 18th respondents are far senior in service when compared to the 2nd and 3rd petitioners.

I declare that the fundamental rights of the 1st petitioner guaranteed under Article 12(1) of the Constitution has been violated. Accordingly, I direct the 1st and 2nd respondents—the Sri Lanka Rupavahini Corporation and its Chairman—to appoint the 1st petitioner U.P.E. Wijesuriya (Service No. 1423) to the post of Technical Administrator, with effect from 01.08.2014, without payment of arrears of salary, in the same manner as was done in respect of the 15th to 18th respondents.
