The Petitioners are Head Quarters Sports Officers of the Department of Sports Development. The Public Service Commission (PSC) by Notice published in the Gazette dated 17-11-2017 called for applications from suitable persons to fill 3 posts of Assistant Director (Sports) of Supervisory Category III in the Department of Sports Development. **Clause 4** of the said Gazette has set out the necessary qualifications and experience in the following manner:

*“04. Educational, Professional qualifications and experience :*

*(I) Should be a Supra Grade officer in the sports officers' service of the Department of Sports Development*

*or*

*(II) Should be a Supervisory Management Assistant Technological Grade I officer of Sports Officers' Combined service of the Department of Sports Development*

*or*

*(III) Should be a Supervisory Management Assistant Technological Grade II of Sports officers' combined service of the Department of Sports Development, and should possess a Degree related to Sports or Management field, obtained from a university recognized by the University Grant Commission*

*or*

*(IV) Should be an officer of Sports Officers' Combined Service in the Department of Sports Development, with 10 years active and satisfactory period of service and should have obtained a Degree related to the field of Sports from a university recognized by the University Grants Commission.”*

The Petitioner has produced this Gazette marked **P15(a)**.

**Clause 8** of the said Gazette [**P14(a)**] has described the relevant marking scheme applicable to the evaluation of the above qualifications. It is as follows:

The Petitioners have complained that the above marking scheme is not clear as to whether their past service they have had in the posts junior to their current post (Head Quarters Sports Officer) must be taken into account and allotted marks on the basis that they have possessed additional service experience.

As pointed out by the learned Deputy Solicitor General, I have no doubt that four limbs I, II, III, IV under **Clause 4** must be referable directly to each sub limbs I, II, III, IV under additional service experience (**Clause 8**). In other words, this can be inserted into one table which should appear as follows:

As all the Petitioners were Head Quarters Sports Officer, they had applied under the First Category in **Clause 4**. Therefore, the marks they are entitled to is 5 marks for each year from the date of appointment to that post (Head Quarters Sports Officer).

The Petitioners have joined the Department of Sports Development as sports officers on 06-01-1986. Thereafter they were promoted to the post of sports coach with effect from 01-09-1999. Then they were promoted to the post of Project Officer with effect from 06-07-2015. The new service minute of the combined service of officers in the field of sport of the Department of Sports Development which was published in the Government Gazette (Extra Ordinary) dated 26-09-2016, the Petitioners who were in the post of project officer were absorbed to the post of Head Quarters Sports Officer with effect from 26-09-2016. This was the Petitioner's past career development. Thus, what the Petitioners insist in the instant case is that they should be awarded marks for each year they spent in their previous posts.

I regret my inability to accept this argument. The Scheme of Recruitment has been designed to enable candidates from all four categories to apply. If Petitioners' argument is to be accepted, the candidates from the other three categories will not be able to compete with the Petitioners. This is because the Petitioners will score more as invariably they have passed all those three junior posts in their career. It will then be impossible for the PSC to select the best from the candidates.

Prior to becoming Head Quarters Sports Officer the Petitioners have held three posts below the post of Head Quarters Sports Officer. The experience the Petitioners could have gained in each post would have been relevant for the promotion to their next

level in the past. The primary qualification under **Clause 4** is for a candidate applying under Category 4(I) is to be a Supra Grade officer in the Sports Officer's Service of the Department of Sports Development. Thus, they are entitled to 5 marks for each year from their date of appointment for the post of Supervisory Management Assistant in the sports officers combined service (Head Quarters Sports Office). Therefore, marks allotted under II, III, and IV, are marks which are respectively allotted only to candidates applying from Categories II, III, IV under **Clause 4**.

Under **Clause 8**, 20 marks have been allotted for special skills performed in the post of Coach and Sports Officer (Head Quarters) which is as follows.

The Petitioners in the instant case have complained that the order of marks under special skills performed in the posts of coach and Head Quarters Sports Officer is irrational and unreasonable as lesser marks are allotted for Commonwealth and World Championships (5 marks) while more marks have been allotted for National Level (10 marks). The Petitioners have suggested the following order of awarding marks to meet the reasonable allocation of marks:

- i. Olympic/World Championship/Paralympics/Para World Championship
- ii. Commonwealth Games
- iii. Asian Games/Para Asian Games
- iv. South Asian Games

v. National Level/National Para Games<sup>1</sup>

Having regard to the Scheme of Recruitment [**P14(a)**], I observe that both arguments advanced by the Petitioners are directly attacking the Marking Scheme. However, the PSC has published the Marking Scheme by the Gazette dated 17-11-2017 itself. This is the same Gazette which calls for applications for the post of Assistant Director (Sports). Petitioners have filed this case on 28-08-2018. Thus, Petitioners have directly impugned this Marking Scheme **P14(a)** in this Petition. Petitioners admittedly have participated in this process of selection but failed. It was in that backdrop that the learned Deputy Solicitor General raised a preliminary objection against the maintainability of this case by the Petitioners on the basis of time bar. As Article 126(2) of the Constitution demands that any Petitioner must file the Petition within one month of their violation of any Fundamental Right. However, the Petitioners have failed to comply with this requirement. Thus, the Preliminary Objection raised by the learned Deputy Solicitor General has to be upheld. I have described above, the merits of this Petition. Therefore, nevertheless I must say that even on merits the Petitioners are not entitled to succeed with their Petitions.

For the above reasons I decide to dismiss this Petition without costs.
